3. Seeking to delete the name of the 4th respondent in Patta No. 2657 relating to the property in question, the petitioner has sent a representation to the respondents 1 and 2. However, since the same was not considered so far, the petitioner is before this Court.

In view of the above submissions, this writ petition is disposed of with a direction to the 2nd respondent to consider the representation of the petitioner by conducting enquiry and after giving due notice to the private respondent, pass orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
