ORDER

The Tahsildar, Veerakeralampudhur has filed an affidavit of compliance. Paragraph Nos.5 & 6 of the affidavit reads as follows:-

“5. I respectfully submit that the above encroachments removed as per law in force by way of under Section 7 notice was issued on 21.12.2023 and opportunity was given to the encroachers. Under Section 6 of the Tamil Nadu Land Encroachment Act, 1905 notice was issued to the encroachers. The above mentioned encroachments were removed on 20.01.2024.
