This writ petition has been filed seeking a direction to the first and second respondents to remove the encroachment made by the respondents 3, 4 & 5 in pursuance of their communique in Na.Ka.No. 1316/2023/F1 coupled with the petitioner's representation dated 06.08.2025 in respect of Town Survey No.83 & 84 in Ward-B, Block No. 14 ie. the front portion of petitioner's property which is a promboke land, within a time frame.

After conducting survey, if it is found that there is an encroachment, the same shall be removed, within a period of three months. Accordingly, this writ petition is disposed of.
