2. Heard the learned counsel for the petitioner, the learned Additional Government Pleader appearing for the official respondents and the learned counsel for the private respondents.

3. The petitioner submitted a representation to the official respondents seeking patta. Since no action has been taken on the said representation, the petitioner is before this Court with this writ petition.

4. Learned Additional Government Pleader, appearing for the official respondents, submits that the representation of the petitioner's would be considered by the respondents 2 and 3 within a time stipulated by this Court.

5. In view of the above submissions, without expressing any opinion on the merits of the matter, this writ petition is disposed of with a direction to the respondents 2 and 3 to consider the petitioner's representation dated 11.07.2022 by conducting enquiry by hearing all the parties and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this

order. Needless to say, if any rival claims, the same shall be subject to the jurisdiction of the civil Court. There shall be no order as to costs.
