Prayer: Writ petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the impugned refusal check slip under refusal No.RFL/Kanyakumari Joint No.I/64/2025 passed by the first respondent dated 07.10.2025 and to quash the same as illegal and further to direct the first respondent to register the sale deed dated 30.09.2025 executed by the petitioner relating to the land having extent of 3.054 cents equivalent to 123.626 Sq.mtr. comprised in new S.No.174/2A1 correlating to S.No.174/2 situated at now Vadiveeswaran East Village erstwhile Vadiveeswaram Village, Agastheeswaram Taluk, Kanyakumari District.

ORDER
