ORDER

The petitioner/accused in Spl.SC No.70 of 2017 on the file of the Principal Special Court for Exclusive trial of cases under POCSO Act, Madurai, has filed this petition to suspend the sentence imposed on him by the trial Court, for the offence under Sections 3,4,5(m) and 6 of POCSO Act, 2012 and Section 506(1) IPC.

2.It is reported that this is the eighth application filed by the petitioner for suspension of sentence. The earlier applications filed by this petitioner in Crl.MP(MD) Nos.7234 of 2023, 10146 of 2023, 13490 of 2023, 15093 of 2023, 17964 of 2023, 8558 of 2024 and 2981 of 2025 were dismissed by this Court, by its orders, dated 23.06.2023, 17.07.2023, 20.10.2023, 17.11.2023, 08.04.2024, 24.09.2024 and on 27.03.2025 respectively, considering the grave nature of offence committed by this petitioner.
