2. Today, the petitioner submitted that he is ready and willing to deposit a sum of Rs.5,00,000/- (Rupees Five lakhs only) immediately and seeks time to deposit another Rs.5,00,000/- (Rupees Five lakhs only).

3. Considering the same, this Court directs the petitioner to deposit Rs.5,00,000/- (Rupees Five lakhs only) forthwith. The balance amount of Rs. 5,00,000/- (Rupees Five lakhs only) shall be deposited on or before 30.03.2026, failing which, the anticipatory bail already granted shall be automatically vacated.
