(MD)No.85 of 2026. The Division Bench has disposed the the said writ appeal, by its order dated 02.02.2026, directing the respondents to pay a sum of Rs.5,00,000/- to the petitioner on or before 27.04.2026. An additional time limit has also been granted to the respondents to pay the balance amount of Rs.5,00,000/- to the petitioner on or before 15.07.2026.
