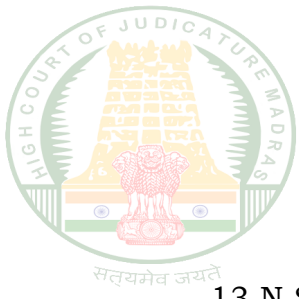

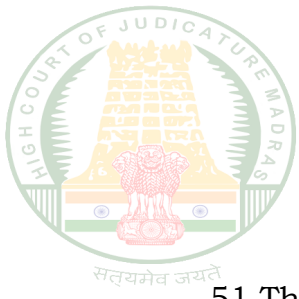

ORDER

Heard Ms.J.Roshini representing Mr.T.Balarathinakumar for petitioner and Mr.S.Ramesh for the 1st Respondent and Mr.A.K.Manikkam for Respondents No.4, 11, 12, 15, 20, 23, 29 & 38.

2. Mr.S.Ramesh reports that the Civil Revision Petitioner is proposing to take the bundle back from him. On 30.04.2026, I had informed the Civil Revision Petitioner that alternate arrangements would have to be made, and I listed the matter today (11.06.2026). Even after 1½ months, alternate arrangements have not been made. A litigant cannot obtain an interim order and thereafter avoid proceeding further with the revision. The plaintiff has moved the vacate stay application and is insisting that the stay be vacated.
