This Court, vide order dated 10.02.2026, had directed the learned Sub Judge, Paramakudi, to send a year wise pendency report of the pending suits and in compliance of the same, the learned Sub Judge Court, Paramakudi, had sent a report vide proceedings in D.No.183, dated 18.02.2026, annexing the breakup details with regard to the pendency of the cases arising from the year 2022 to till date, which was addressed to the Registrar (Judicial) of this Court. From the perusal of the same, it is seen that the total number of pending cases is 66 and the pendency of E.P in the year 2022 is 12.
