ORDER

This Civil Revision Petition has been filed seeking a direction to the learned District Munsif, Uthamapalayam, to dispose of the case in E.P.No.57 of 2021 in O.S.No.80 of 2011, within a time frame fixed by this Court.

2.This Court, vide order, dated 02.02.2026, had directed the learned District Munsif, Uthamapalayam, to send a year wise pendency report of the pending cases and in compliance of the same, the learned District Munsif, Uthamapalayam, had sent a report vide proceedings in D.No.131/2026, dated 16.02.2026, annexing the breakup details with regard to the pendency of the cases arising from the year 2011 to 2026.
