2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3.While granting suspension of sentence, this Court imposed the condition directing the petitioner to appear before the Sessions Judge, Mahila Fast Track Court, Dindigul, daily at 10.30 a.m till the disposal of the appeal. The present petition is filed seeking to relax the said condition.

4. The petitioner states that he is a daily wager and his entire family members depend on his income alone. Because of the condition imposed on the petitioner, he is not able to go to work. The petitioner therefore seeks for relaxation of the condition imposed by this Court.
