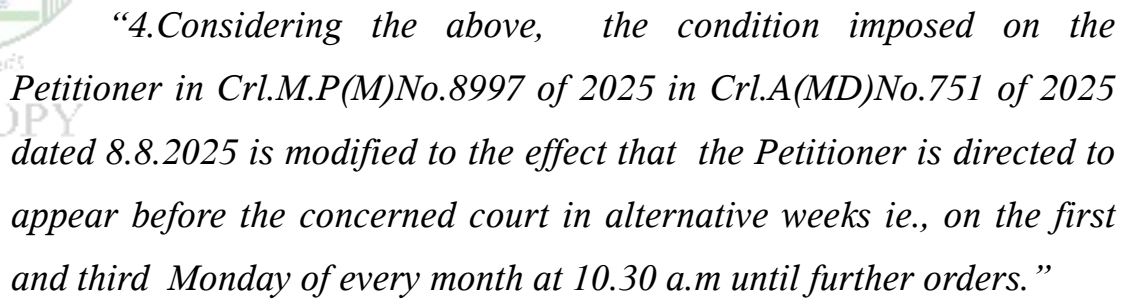

ORDER

This Petition is filed to relax the condition imposed by this Court in CrI.MP(MD) No.12963/2025 in CrI A(MD) No.751/2025 vide its order, dated 24.09.2025.

2.The Petitioner is the third accused and was found guilty and convicted for the offence under Section 307(2) of IPC and sentenced to undergo 10 years rigorous imprisonment and to pay a fine of Rs.5,000/-, in default, to undergo six months rigorous imprisonment by the learned Sessions Judge, Tuticorin. The Petitioner earlier filed suspension of sentence application in CrI.M.P(MD)No.8997 of 2025 and this Court allowed the application by imposing conditions stated therein. The Petitioner filed a second application in CrI.M.P(MD)No.12963 of 2025 and prayed for relaxing the condition No.2 in the order, dated 8.8.2025.This Court vide order dated 24.09.2025 relaxed the condition No.2 to the following effect:
