COMMON ORDER

The petitioners/Accused 1 & 2 in SC.No.22 of 2021, on the file of the Additional Sessions Court (Fast Track Mahila Court), Karur were found guilty by the trial Court and convicted and sentenced as under:-

1.	366 IPC	10 years Rigorous imprisonment each	Rs.1,000/- each	1 year simple imprisonment each
2.	376(2)(1) IPC	10 years Rigorous Imprisonment each	Rs.1,000/- each	1 year simple imprisonment each
3.	376(2)(D) IPC	20 years Rigorous Imprisonment each	Rs.1,000/- each	1 year simple imprisonment each

As against the conviction and sentence imposed by the trial Court in S.C.No.22 of 2021, dated 17.05.2022, the petitioners have filed Criminal Appeals in Crl.A(MD) Nos.638 of 2022 & 138 of 2026. The

petitioners have also moved these applications to suspend the sentence imposed on them by the trial Court. The earlier application filed by A1 in Crl.MP(MD) No.12351 of 2022 to suspend the sentence was dismissed by this Court, by order, dated 19.10.2022. Insofar as A2 is concerned, this is the first application for suspension of sentence.

2.When these applications are taken up for hearing, it is reported that the typed set of papers are made ready. The learned Additional Public Prosecutor appearing for the respondent is also ready to proceed with the appeals.

3.Since it is reported that the typed set of papers are made ready, these Criminal Miscellaneous Petitions are dismissed. Registry is directed to list the Criminal Appeals on priority, under the caption "accused on jail cases", for final disposal.
