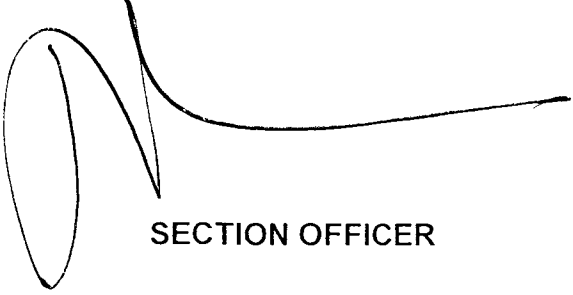
JUDGMENT: (Per Hon'ble Justice Moushumi Bhattacharya)

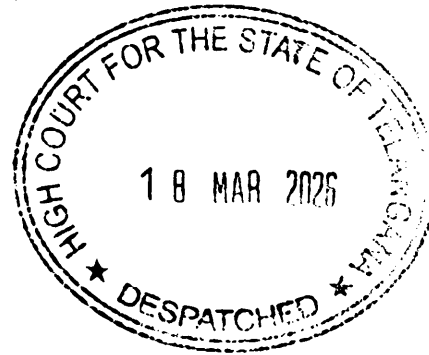
