ORDER:

This Criminal Petition is filed seeking the Court to enlarge the petitioner on bail, who is arrayed as accused No.2 in FIR No.11 of 2026 of Railway Police Station, Hyderabad, registered for the offences punishable under Sections 8(c) r/w 20(b)(ii)(B) of the NDPS Act, 1985.

2. The brief facts of the case are that on 21.01.2026, the de-facto complainant, on reliable information had conducted inspection and found the petitioner herein along with other accused and on verification, they found 16.452 kgs of Ganja in possession of the accused and seized the contraband and a case was registered against them for the above said offences.

3. Heard Sri Kallu Sunil, learned counsel appearing on behalf of the petitioner as well as Sri M. Ramachandra Reddy, learned Additional Public Prosecutor appearing for the respondent-State.

4. Learned counsel for the petitioner submitted that the petitioner is innocent of the said allegations and she is falsely implicated in this case and she is in jail since 21.01.2026 and the seized contraband is 16.452 kgs of Ganja, which is an intermediate quantity and she is also suffering with severe health problems. Therefore, he prayed the Court to grant bail to the petitioner by allowing this criminal petition.

5. On the other hand, learned Additional Public Prosecutor opposed the submissions made by the learned counsel for the petitioner stating that the alleged offences are of the NDPS Act, as such, she is not entitled for the bail. Further, the

investigation is not yet completed. However, he informed that there are no other cases pending against the petitioner. Therefore, he prayed the Court to dismiss the criminal petition.

6. In the light of the submissions made by both the learned counsel and upon perusal of the material available on record, it appears that the petitioner herein is in jail from 21.01.2026 and the seized contraband is 16.452 kgs of Ganja, which is an intermediate quantity. Further, there are no other cases pending against the petitioner and she is also suffering with severe health problems. Considering the facts and circumstances of the case, the nature of the allegations, the stage of investigation, the duration of incarceration and the seized contraband, this Court finds it appropriate to grant bail to the petitioner, subject to the following conditions:

- i. The petitioner shall execute a personal bond for a sum of Rs.15,000/- (Rupees Fifteen Thousand only), with two sureties for a like sum each to the satisfaction of the learned II Judicial Magistrate of First Class for Railways, at Secunderabad.

- ii. The petitioner shall appear before the concerned SHO at 11:00 a.m., on every Monday for a period of eight (8) weeks or till filing of charge sheet whichever is earlier, for the purpose of investigation, and thereafter, as and when required.
- iii. The petitioner shall abide by the conditions stipulated in Section 437(3) of Cr.P.C. (presently, Section 480(3) of the BNSS).

7. Accordingly, the Criminal petition is allowed.

Miscellaneous applications, if any pending, shall stand closed.
