**ORDER:**

When the matter was taken up for hearing earlier on 08.04.2026, learned counsel for petitioner on record informed this Court that they have given up Vakalat and the matter was being adjourned from time to time. On 17.06.2026, there was no representation on behalf of the petitioner. Accordingly, the matter was directed to be posted under the caption "For Dismissal" to today.

2. Today, when the matter is taken up for hearing, Mr.Tejaswini Mereddy, learned Standing Counsel for HMRL, for the respondent Nos.2 and 3 and Mr.N.Uma Shankar, learned

Standing Counsel for Agriculture Market Committee for respondent Nos.4 and 5 are ready to proceed with the matter. However, there is no representation on behalf of the petitioner though the matter is listed under the caption "For Dismissal". Despite taking no objection Vakalat from the counsel, the petitioner has not engaged any other counsel. It indicates that the petitioner is not interested in pursuing the writ petition.

3. Accordingly, the Writ Petition is dismissed for non-prosecution. There shall be no order as to costs.

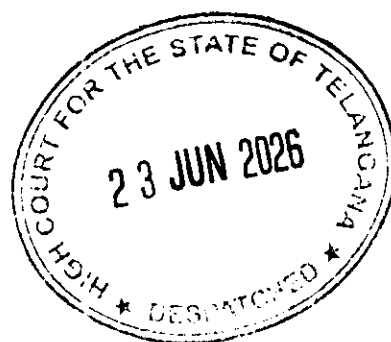
