ORDER:

This Criminal Petition is filed seeking the Court to enlarge the petitioner on bail, who is arrayed as accused No.2 in Crime No.678 of 2026 of Vanasthalipuram Police Station, Malkajgiri District, registered for the offences punishable under Sections 8(c) r/w 20(b)(ii)(B) and 27 of the NDPS Act, 1985.

2. The brief facts of the case are that, on 11.04.2026, the de-facto complainant received credible information and

immediately he conducted inspection and found accused persons in possession of 2 kgs of Ganja and seized the contraband and a case was registered against them for the above said offences.

3. Heard Sri CH. Rajkumar, learned counsel appearing on behalf of the petitioner as well as Sri M. Ramachandra Reddy, learned Additional Public Prosecutor appearing for the respondent-State.

4. Learned counsel for the petitioner submitted that the petitioner is innocent of the said allegations and he is falsely implicated in this case and he is in jail since 11.04.2026 and the seized contraband is 2 kgs of Ganja, which is an intermediate quantity and the entire investigation is already completed. Therefore, he prayed the Court to grant bail to the petitioner by allowing this criminal petition.

5. On the other hand, learned Additional Public Prosecutor opposed the submissions made by the learned counsel for the petitioner stating that the alleged offences are of the NDPS Act, as such, he is not entitled for the bail. However, he informed that he has not received any information regarding

the previous history of the petitioner herein. Therefore, he prayed the Court to dismiss the criminal petition.

6. In the light of the submissions made by both the learned counsel and upon perusal of the material available on record, it appears that the petitioner herein is in jail from 11.04.2026 and the seized contraband is 2 kgs of Ganja, which is an intermediate quantity. As seen from the remand case diary, the prosecution witnesses, LWs 1 to 11 have already been examined. Considering the facts and circumstances of the case, the nature of the allegations, the stage of investigation, the duration of incarceration and the seized contraband, this Court finds it appropriate to grant bail to the petitioner, subject to the following conditions:

- i. The petitioner shall execute a personal bond for a sum of Rs.15,000/- (Rupees Fifteen Thousand only), with two sureties for a like sum each to the satisfaction of the learned VII Additional Judicial Magistrate of First Class-cum-VII Metropolitan Magistrate, Ranga Reddy District, at Hayath Nagar.

- ii. The petitioner shall appear before the concerned SHO at 11:00 a.m., on every Monday for a period of eight (8) weeks or till filing of charge sheet whichever is earlier, for the purpose of investigation, and thereafter, as and when required.
- iii. The petitioner shall abide by the conditions stipulated in Section 437(3) of Cr.P.C. (presently, Section 480(3) of the BNSS).

7. Accordingly, the Criminal petition is allowed.

Miscellaneous applications, if any pending, shall stand closed.
