Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of Respondent No.2 in not renewing Petitioner's Passport bearing No. K6891497 pursuant to application vide File No. HY1076941089326, on the ground that the petitioner was involved in a criminal case is illegal, arbitrary, unconstitutional and consequently direct the Respondent No.2 Permit the petitioner to travel to the United States of America for the period from 15th July 2026 to 30th August 2026 for attending ATA Conference and Official engagement.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.2 to consider the Petitioner's application vide File No. HY1076941089326 for renewal of Petitioner's Passport bearing No. K6891497, pending disposal of the main writ petition.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.2 Permit the petitioner to travel to the United States of America for the period from 15th July 2026 to 30th August 2026 for attending ATA Conference and Official engagement, pending disposal of the writ petition.

ORDER: (ORAL)

Heard Sri. Gajanand Chakravarthi, learned counsel for the petitioner, and Mrs.N.V.R. Rajyalakshmi, learned Standing Counsel for the Central Government representing Sri N. Bhujanga Rao, learned Deputy Solicitor General of India appearing for the respondents and perused the material available on record.

2. Learned counsel for the petitioner submitted that two (02) criminal cases are presently pending against the petitioner, viz., (i) C.C. No.3654 of 2022 on the file of the Court of the III Additional Judicial Magistrate of First Class, Hanamkonda, for the offences punishable under Section 171-E of the IPC and Section 123(1) of the Representation of the People Act, 1951 and (ii) C.C. No.635 of 2024 on

the file of the Additional Judicial Magistrate of First Class-cum-Additional Junior Civil Judge, Bhongir, for the offences punishable under Sections 188, 337 and 286 of the IPC.

3. Learned counsel further submitted that the petitioner has received an invitation from the American Telugu Association (ATA) to participate in the 19th Youth Convention to be held at Baltimore, United States of America, from 31.07.2026 to 02.08.2026. It is submitted that the petitioner filed CrI.M.P. No.330 of 2026 in C.C. No.635 of 2024, and the learned Additional Judicial Magistrate of First Class-cum-Additional Junior Civil Judge, Bhongir, by order dated 23.06.2026, permitted the petitioner to renew his passport. Learned counsel further submitted that the petitioner also filed CrI.M.P. No.591 of 2026 in C.C. No.3654 of 2022 before the Court of the III Additional Judicial Magistrate of First Class, Hanamkonda, seeking similar permission. However, the said application has not yet been taken up for consideration.

4. It is submitted that, as the petitioner is required to travel to the United States of America on or before 15.07.2026 to make necessary arrangements prior to the commencement of the convention, and in view of the delay in disposal of the said application, the petitioner has been constrained to approach this Court.

5. In view of the submissions made by the learned counsel for the petitioner, the writ petition is disposed of directing the learned III Additional Judicial Magistrate of First Class, Hanamkonda, to pass appropriate orders in Crl.M.P. No.591 of 2026 in C.C. No.3654 of 2022, in accordance with law by affording opportunity of hearing, within a period of three (03) days from the date of receipt of a copy of this order. The petitioner shall obtain the requisite permission from the Court of the III Additional Judicial Magistrate of First Class, Hanamkonda, in C.C. No.3654 of 2022, as well as from the Court of the Additional Judicial Magistrate of First Class-cum-Additional Junior Civil Judge, Bhongir, in C.C. No.635 of 2024, before undertaking his travel to the United States of America. There shall be no order as to costs.

As a sequel thereto, miscellaneous applications, if any, pending in this writ petition, shall stand closed.

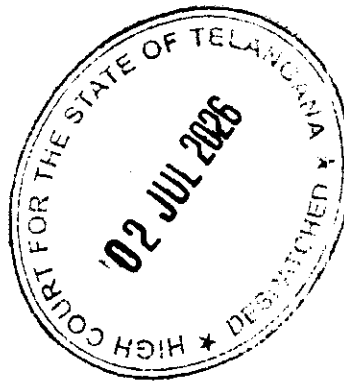
