1. The present is an execution application filed by the applicant-petitioner which is a foreign company.

2. On 09.01.2026, following order was passed by this Court:-

*“On the last date of hearing i.e. on 27.11.2025, the following order was passed:-*

*“Learned counsel for the petitioner, who has joined the proceedings through video conferencing, has prayed for some more time to file the list of properties. However, a perusal of the last two orders would show that time had already been granted to the petitioner for furnishing the list of properties.*

*In view of the above, the request of learned counsel for the petitioner is accepted, subject to payment of costs of Rs.10,000/-, to be deposited by the petitioner with the High Court Legal Services Committee, Hon'ble Punjab and Haryana High Court, Chandigarh.*

*Adjourned to 09.01.2026."*

*Learned counsel for the petitioner has caused appearance through video conferencing and submitted that the petitioner is a foreign Company based in China and therefore, the costs of ₹10,000/- could not be deposited. He prays for some more time to deposit the aforesaid costs and also to furnish the list of properties of the petitioner.*

*The mere fact that the petitioner-Company, which is seeking enforcement of a foreign award, is based in China, would not mean that it will not deposit the costs or furnish the list of properties.*

*However, in the interest of justice, one more opportunity is granted to the petitioner, subject to deposit of additional costs of ₹10,000/- (Rupees Ten Thousand only).*

*It is made clear that if on or before the next date of hearing, the list of properties and the aforesaid total costs of ₹20,000/- (i.e. ₹10,000/-+ ₹10,000/-) are not deposited, then this Court will consider the dismissal of the present application.*

*Adjourned to 04.02.2026.”*

3. None has caused appearance on behalf of the petitioner today.

4. The Registry of this Court has reported that the costs have not been paid by the petitioner since no receipt has been furnished. The report of the Registry is reproduced as under:-

*“Receipt of costs of Rs.20,000/- as well as list of properties not received so far.”*

5. Since on 09.01.2026, this Court had made it clear that if, on or before the next date of hearing, the list of properties is not furnished and the costs are not deposited, then this Court will consider the dismissal of the present execution application, even till date the list of properties has not been furnished and the costs have not been deposited by the petitioner, coupled with the fact that the learned counsel for the petitioner has also not appeared today, this Court has no option but to dismiss the present execution application.

6. The present application is hereby dismissed.
