VIRINDER AGGARWAL, J. (Oral)

1. Instant petition has been filed under Section 528 of BNSS, seeking quashing of FIR No.181 dated 23.10.2025 registered under Sections 333, 115(2), 191(1), 190 of the Bharatiya Nyaya Sanhita (BNS), 2023 at Police Station Sadar, Shri Muktsar Sahib, District Police Sadar Shri Muktsar Sahib and all the consequential proceedings arising therefrom, on the basis of the compromise dated 30.12.2025 (Annexure P-2), effected between the parties.

2. Vide order dated 28.04.2026, the affected parties were directed to appear before the learned Trial Court/Illaq Magistrate, for getting their respective statements recorded with regard to the compromise.

3. Report has since been received from learned District and Sessions Judge, Sri Muktsar Sahib, in pursuance to the directions of this Court wherein, the factum of the compromise arrived at between the parties



stands verified and confirmed. As per the report(s) compromise has indeed been effected between the parties and the same is without any pressure or coercion and out of their free will and the private respondents have also made statement to the effect that they would have no objection if the FIR qua the accused-petitioners is quashed.

4. The trial Court has annexed the statements of the parties in original, along with its report.

5. Learned State counsel too submits that there are no other accused other than the petitioners and the private respondents are the only aggrieved persons in the FIR in question.

6. In view of the report of the learned District & Sessions Judge, Sri Muktsar Sahib, and the principles laid down by Hon'ble the Apex Court in **Gian Singh Vs. State of Punjab and others (2012) 10 SCC 303**, and also by the Full Bench of this Court in **Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR (Criminal) 1052**, the instant petition is allowed. The aforesaid FIR and all consequential proceedings arising out of it qua petitioners, are hereby quashed.

7. Needless to say the parties shall remain bound by the terms of compromise and their statements recorded before the Court below.

8. Petition stands disposed of.
