1 Petition herein is, *inter alia*, seeking a writ in the nature of Mandamus, directing the respondents No.2 and 3 to adhere to and honour the order dated 31.08.2021 (Annexure P-1) passed by learned Civil Judge (Junior Division), Mukerian and order dated 25.08.2025 (Annexure P-2) passed by learned Additional District Judge, Hoshiarpur.

2. There is no representation on behalf of the petitioner today.

3. Mr. Lalit Goyal, Advocate appears in pursuance of the advance copy of paper book having already been supplied to him and files Memorandum of Appearance on behalf of respondents No.2 and 3 in Court today, which is taken on record, subject to all just exceptions.

4. A perusal of the order dated 31.08.2021 (Annexure P-1) shows that the same has been passed on an application for stay filed by petitioner in Civil Suit No.459/2020 under Order 39 Rules 1 and 2 of CPC; however appeal preferred by the Municipal Committee, Mukerian against the abovesaid order dated 31.08.2021 (Annexure P-1) has been dismissed vide

order dated 25.08.2025 (Annexure P-2) passed by learned Additional District Judge, Hoshiarpur.

5. It is noticed from order dated 31.08.2021 (Annexure P-1) as well as order dated 25.08.2025 (Annexure P-2) that the parties to the suit have been directed to maintain status quo qua possession.

5.1 In my considered view; if the petitioner is aggrieved by the non-compliance of order dated 31.08.2021 (Annexure P-1) and/or order dated 25.08.2025 (Annexure P-2), then he may avail his remedies in terms of Order 39 Rule 2A of CPC, in accordance with law; however the prayer made in the present writ petition is not maintainable before this Court, and the same is accordingly dismissed.

6. All the pending application(s), if any, shall also stand closed.

7. A copy of this order be sent to petitioner as well as learned counsel for the petitioner.
