1. The present petition has been filed by the petitioners under Articles 226/227 of the Constitution of India, seeking issuance of a writ of mandamus, directing the respondents to grant the petitioners pay scale and allowances as per Punjab Health and Family Welfare Technical (Group 'C') Service Rules, 2016 along with all allowances applicable under the Punjab Pay Scale Matrix with further revision in view of judgment passed by this Court in ***CWP-15896-2023 titled as 'Saurabh Sharma and others Vs. State of Punjab and another'*** ***decided on 13.09.2024*** (Annexure P-6).

2. Learned counsel for the petitioners submits that for redressal of their grievances, the petitioners have also served legal notice dated 16.12.2025 (Annexure P-11) to the respondents which is still pending consideration. He further submits that at this stage, the petitioners would be satisfied, if appropriate directions are issued to the respondents to consider and decide the said legal notice, by passing a speaking order, in a time bound manner.

3. Notice of motion.

4. Mr. Satnampreet Singh Chauhan, D.A.G., Punjab, accepts notice on behalf of respondents No.1 to 3-State. Mr. Shailesh Aggarwal, Advocate has put in appearance on behalf of respondent No.4 and filed his power of attorney in the Court which is taken on record. They have no objection to the innocuous prayer made by learned counsel for the petitioner.

5. I have heard learned counsel for the parties and have gone through the record of the case.

6. Without going into the merits of the case at this stage, the present petition is disposed of with a direction to respondent No.4 to consider and decide legal notice dated 16.12.2025 (Annexure P-11) submitted by the petitioners expeditiously, by passing a speaking order after affording an opportunity of hearing to the petitioners, preferably within a period of 03 months from the date of receipt of certified copy of this order. Further, the decision taken thereon shall be conveyed to the petitioners. Needless to say, if the petitioners are found entitled to the relief sought, the same shall be granted to them within a period of 01 month thereafter.
