1. By way of present appeal, challenge has been laid to an award dated 04.10.2011 passed by the learned Motor Accident Claims Tribunal, Sri Muktsar Sahib (for short' "Tribunal"), vide which compensation to the tune of Rs.2,50,000/- along with interest @ 7% per annum was awarded to the claimant, while granting recovery rights to the Insurance Company against the owner (appellant) of the offending vehicle.

2. At the outset, learned counsel for the appellant wishes to withdraw the present appeal.

3. Allowed as prayed for.

4. In terms thereof, the statutory amount, if any, deposited by the appellant, be refunded.
