Sumeet Goel (Oral):

1. Apprehending his arrest in FIR No.193 dated 16.11.2023 registered for offences punishable under Section 18 & 29 (added later on) of NDPS Act, at Police Station Civil Lines Patiala, District Patiala; the petitioner has preferred this petition under Section 482 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking pre-arrest bail.

2. On 14.05.2026, the following order was passed:

“Apprehending his arrest in FIR No.193 dated 16.11.2023 registered for offences punishable under Section 18 & 29 (added later on) of NDPS Act, at Police Station Civil Lines Patiala, District Patiala; the petitioner has preferred this petition under Section 482 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking pre-arrest bail.

*Counsel for the petitioner, inter alia, contends that the petitioner is sought to be implicated into the FIR in question solely on the basis of a disclosure statement made by co-accused from whom the contraband in question has been allegedly recovered & the petitioner is willing to join investigation and cooperate therein. In order to buttress his arguments, learned counsel for the petitioner has relied upon the dicta of the judgments of the Hon'ble Supreme Court in '**Vijay Singh versus The State of Haryana**' bearing **Special Leave to Appeal (Crl.) No(s).1266/2023**, '**State by (NCB) Bengaluru vs. Pallulabid Ahmad Arimutta & Anr**' **2022(1) RCR (Criminal) 762**, '**Tofan Singh vs. State of Tamil Nadu**, AIR 2020 Supreme Court 5592, '**Smt. Najmunisha, Abdul Hamid Chandmiya @ Ladoo Bapu vs. State of Gujrat, Narcotics Control Bureau**' **2024 INSC 29** and '**Jugraj Singh Vs. State of Punjab**' bearing **Special Leave to Appeal (Crl.) No.9190/2025**.*

Notice of motion.

On the strength of advance notice; Mr. Adhiraj Singh, AAG, Punjab has entered appearance on behalf of the respondent-State of Punjab.

Adjourned to 29.05.2026. Be taken up in the urgent cause list.

State is at liberty to file reply, if so required.

The petitioner is directed to appear before the Investigating Officer on 16.05.2026 at 11:00 A.M. in concerned Police Station and join investigation. In the event of arrest, the petitioner shall be released on interim bail subject to his furnishing personal/surety bond(s) to the satisfaction of the Arresting Officer/Investigating Officer. As and when further called by Investigating Officer, the petitioner shall join the investigation. He shall abide by the condition(s) enumerated under Section 482(2) of Bharatiya Nagarik Suraksha Sanhita, 2023."

3. Learned State counsel has filed status report by way of affidavit of Deputy Superintendent of Police, City-1, Patiala, which is taken on record. Further, he (on instructions from HC Navdeep Singh) has

submitted that the petitioner has joined investigation but his custodial interrogation is required for giving out whereabouts/details of the co-accused.

4. Keeping in view the factual milieu of the case in hand, especially the factum of the petitioner having joined investigation, he being arrayed as an accused on the basis of disclosure statement and his custodial interrogation is being sought for to ascertain the whereabouts/details of the co-accused, this Court is inclined to confirm the order dated 14.05.2026, in light of the *dicta* of the judgment passed by this Court in **CRM-M-54032-2024 ‘Ashu Vs. State of Punjab’** and recent judgment of the Hon’ble Supreme Court passed in **‘Jugraj Singh Vs. State of Punjab’** bearing ***Special Leave to Appeal (Crl.) No.9190/2025***.

5. Accordingly, the petition is allowed and the order dated 14.05.2026 granting interim anticipatory bail to the petitioner is hereby made absolute, subject to the conditions as enumerated under Section 482(2) of BNSS.

6. This order should not be treated as “blanket” order. It will not be read granting petitioner indefinite protection from arrest. It shall be confined to the FIR mentioned *ibid* and will not operate in respect of any other incident that involves commission of an offence.

7. Liberty is reserved in favour of State/complainant to move for cancellation/recall of this order in case the petitioner violates any condition stipulated under Section 482(2) of BNSS or upon showing any other sufficient cause.

8. Needless to say that anything observed herein above shall not be construed to be an opinion on the merits of the case.
9. Pending application(s), if any, shall also stand disposed off.
