Petitioner-Amanpreet Singh has filed the instant petition under Section 483(3) of BNSS, seeking cancellation of anticipatory bail granted by learned Additional Sessions Judge, SAS Nagar, Mohali, to respondent No.4- Ravinder Singh @ Roda, vide order dated 28.05.2025 (Annexure P-3) in case FIR No.0001 dated 17.01.2025 under Sections 109, 118(1), 115(2), 3(5) and 351(2) of BNS, 2023 and sections 117(2), 118(2), 191(3), 190 of BNS, 2023 (added later), whereas offence under Sections 115(2), 3(5) of BNS, 2023 has been reduced, registered at Police Station Block Majri, District SAS Nagar, Mohali.

2. After examining the application for bail, following was recorded by the trial Court in the order dated 14.05.2025 (Annexure P-5):-

“3 Perusal of the record indicates that the FIR has been registered on the complaint made by complainant, interalia, alleging that on the morning of 16.01.2025, he alongwith his paternal uncle (Tayaji) Harchand Singh had gone to their field then one Black Colour Baleno stopped and four people came out of it from which one Dharminder Singh @Nanni son of Sadhu Singh armed with Kirpal, Chamanrpeet Singh @ Chinni armed with Gandasa, Ravinder Singh @ Roda armed with Kuhadi and one unknown person armed with danda attacked upon his paternal uncle Harchand Singh. Dharminder Singh @ Nanni gave a kirpan blow on the head of Harchand Singh with the intention to kill him. His uncle fell down. Ravinder Singh @ Roda gave a axe blow on his right leg. He tried to stopped them but they threatened him that if he came to stop then then they will not spare him. He ran away from the spot and raised hue and cry. Chamanrpeet Singh @ Chinni gave gandsa blow on the left leg of his uncle. One unknown person gave danda blow on the left leg of his uncle. Thereafter, they ran away from the spot.

4 Perusal of the file shows that initially the FIR was registered on the statement of Amanpreet Singh. Accused has caused injuries on the persons of Harchand Singh who is paternal uncle (Taya) of complainant alongwith Dharminder Singh @ Nanni. During investigation, accused were found to be not present at the spot by the police and DDR no. 10 dated 26.04.2025 shows that initially the accused were found to be innocent but later, on the statement of Dharminder Singh @ Nanni, accused Ajay Billa and Deepak Bedi were nominated in the case and during their investigation, it came out that both the accused have conspired with each other in order to wrongly nominate accused Ajay Billa and Deepak Bedi and they were again nominated in this case. Accused Dharminder Singh @Nanni is in custody and challan against him has already been presented. So, at this stage, there is two contradictory stands of the police qua the accused.”

3. Therefore, respondent No.4 was directed to join investigation. It was on joining of investigation, said interim bail was confirmed by the Court below on 28.05.2025.

4. I have examined the orders. No illegality could be pointed out by learned counsel for the petitioner which may warrant to cause any interference in the order dated 14.05.2025 and 28.05.2025.

5. Accordingly, the petition is dismissed.
Pending application(s), if any, also stands disposed of accordingly.
