SUDEEPTI SHARMA J. (Oral)

1. The present contempt petition has been filed for deliberate and intentional disobedience of order dated 21.11.2024 passed by this Court in CWP-26863-2015, titled as “Malkit Singh & Others Vs. State of Punjab and Others”.

2. Learned counsel for respondents contends that in compliance of order dated 21.11.2024, affidavit of Mr. Jitender Pal Singh, Chief Engineer, Head Quarter, Department of Water Resources, Punjab, Chandigarh, dated 01.04.2026, along with Arrear payment of Malkit Singh S/o Sh. Gian Singh (ECS), dated 19.01.2026, attached as Annexure R-1; letter dated 26.11.2025 of Accountant General, Punjab, with regard to revision of pension of Naginder Singh S/o Mukhtiar Singh, attached as Annexure R-2/T; Arrear payment of Joginder Kaur wife of Sh. Balwinder Singh (ECS), dated 24.12.2025, attached as Annexure R-3; Arrear payment of Joginder Kaur wife of Sh. Jagdish Singh (ECS), dated 29.01.2026, attached as Annexure



R-4; Arrear payment of Parkash Singh husband of Smt. Amarjit Kaur (ECS) dated 14.01.2026, attached as Annexure R-5; Arrear payment of Gurcharan Kaur wife of late Sh. Bikkar Singh (ECS), dated 19.01.2026, attached as Annexure R-6 and Arrear payment of Balraj Singh S/o Sh. Jeet Singh (ECS), dated 14.01.2026, attached as Annexure R-7, has been filed. The same is taken on the record.

3. A perusal of the same shows that order dated 21.11.2024 passed in CWP-26863-2015 has been complied with.

4. In view of the same, the contempt is purged and rule is discharged.
