1. This is a writ petition filed under Article 226 of the Constitution of India seeking the following prayers:

“a. Issue writ of mandamus or any other appropriate writ order, directing the respondent no. 2 (NTA) to provide detail / verify the details of NEET UG score card/ marks of the petitioners ; and/or

b. Issue writ of mandamus or any other appropriate writ, order or direction, directing the NBEMS (respondent no. 1) and NMC (respondent no. 3) to accept the candidature of the petitioners for the FMGE on the basis of UG score card/ marks provided/ verified by NTA and further the requirement on the part of the petitioners to furnish score



card in the application be dispensed with;...”

2. The brief facts of the case are that the petitioners are medical degree holders from foreign Universities and want to appear for Foreign Medical Graduate Examination (“FMGE”), conducted by the National Board of Examinations in Medical Sciences (“NBEMS”). However, the Information Bulletin issued by NBEMS for FMGE, requires mandatory submission of NEET UG Scorecard and the petitioners are unable to find or retrieve their NEET-UG Scorecards for the years 2019, 2020, 2021.

3. Learned counsel for the petitioners, states that the respondent No. 2, namely National Testing Agency (“NTA”) has furnished particulars of the petitioners as available in their database, and the same can be perused by this Court to issue directions to treat this order as NEET UG Scorecards.

4. The respondent No. 2, has filed a counter affidavit mentioning relevant details and particulars of the petitioners, which reads as under:-
