1. Learned Counsel representing the Union of India and Respondent No. 3 have made statements which practically render the present Writ Petitions infructuous.
2. Learned Counsel representing the Union of India states that Respondent No. 3 has withdrawn from the contract, hence a decision has been taken by the government to invite fresh tender(s).
3. Learned Counsel representing Respondent No. 3 confirms its withdrawal from the contract.
4. Keeping in view the aforesaid position, both the Writ Petitions are dismissed as infructuous with liberty to the Petitioner to avail remedies in accordance with law.
