1. The only relief sought in the present batch of four Writ Petitions is for direction to the Standing Screening Committee to decide the candidature of the Petitioners, who have been selected for the post of Constable(GD)/Sub-Inspector (Fire) in Central Industrial Security Force ('CISF').
2. The appointments of the Petitioners have been kept in abeyance in order to verify their antecedents, mostly on account of pendency or decision in criminal cases. The offer of appointment was issued to the



Petitioners on 24.01.2026, and they have been awaiting their joining for the last four months.

3. Keeping in view the aforesaid, and without going into the merits of the case, the present Petitions are disposed of with a direction to the Standing Screening Committee to decide the candidature of the Petitioners positively within a period of one month from today.

4. The pending applications also stand closed.

5. A photocopy of the order passed today be kept in the connected matters.
