1. During the course of hearing, learned counsel for the respondents has handed over an Action Taken Report which was prepared pursuant to the directions contained in the order dated 16.01.2026 passed in the present proceedings. The same reads as under:

**ACTION TAKEN REPORT IN THE CONTEMPT CASE NO. 1235/2025 IN
THE MATTER OF RAJESH KUMAR BHARADWAJ V/S CHIEF SECRETARY,
DELHI AS ON 12/05/26**

It is humbly submitted that the retirement benefits of Shri Rajesh Kumar Bhardwaj were not settled in time as the officer was not clear from vigilance angle at the time of retirement. Hence, provisional pension was granted to him.

Under Secretary, MHA, GoI vide Order No.14033/23/2025-Delhi-II dated 21/11/2025 that "the president, in exercise of power conferred under clause (b) of Sub-Rule (1) of the Rule 8 of CCS(Pension) Rules, 2021 has decided to close the disciplinary proceedings initiated against Shri Rajesh Kumar Bharadwaj, Adhoc DANICS (Retired), Govt. of NCT of Delhi, vide Memorandum No. F.7(29)/2014/DOV/7711 dated 31/07/2014. It is ordered accordingly." The same was communicated to this office by Dy. Director (Vigilance), Directorate of Vigilance, GNCTD vide letter dated 20/12/2025. (copy enclosed for ready reference).

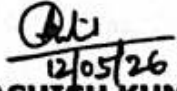

Thereafter,

- this office pursued the matter of granting MACP to Shri Rajesh Kumar Bhardwaj with services department. The MACP was granted by Services Department, GNCTD by order dated 30/03/2026 and third MACP benefits were granted to officer w.e.f. 26/09/2010.
- Pay of Shri Rajesh Kumar Bhardwaj was re-fixed w.e.f. 26/09/2010 upto date of retirement and arrears of MACP were released and credited in the account of the officer.
- Leave encashment payment has also been released to the officer.
- Pension case with revised pay has been sent to the PAO-13, GNCTD on 07/05/2026 for issuance of PPO and release of pension in the account of pensioner.
