1. Instant application has been filed under Section 260A(2A) of the Income Tax Act, 1960 read with Section 5 of the Limitation Act, 1963 seeking condonation of delay of 1359 days in re-filing the appeal.

6. Mr. Ruchir Bhatia, learned Senior Standing Counsel for the appellant is not in a position to dispute this position.
7. In view of the aforesaid and following the above referred orders passed in assessee's earlier appeals, the present appeal is also rejected.
