1. This hearing has been done through hybrid mode.
2. The present petition under Section 24 read with Section 151 of the CPC,  
seeks the following prayers:-

“i. Allow the present transfer petition and thereby transferring the divorce petition so filed by the Respondent bearing **HMA No. 2180/2022 titled as Vikas Singh Vs. Anjali Jayant @Laxmi** pending adjudication in the Court of Ms. Sarita Birbal, Principal Judge Family Court, Shahdara, Karkardooma Courts, New Delhi to the court of Hon’ble Principal Judge, Family Court, North District, Rohini Courts, Delhi.
