1. This is an application under Section 16 of the Court Fees Act, 1870 read with Section 151 of the Code of Civil Procedure, 1908, filed on behalf of the plaintiffs, seeking refund of Court Fees in favour of the Constituted Attorney of the plaintiffs.
2. Learned counsel for the plaintiffs submits that the *inter-se* disputes were amicably settled between the parties and *vide* the order/judgment dated 30.03.2026, the Suit was decreed and disposed of.
3. He states that while decreeing the Suit, this Court had also directed the refund of Court Fees in terms of Section 16 of the Court Fees Act, 1870. Learned counsel for the plaintiffs submits that the present application has been filed seeking permission from the Court for refund of Court Fee in the name of the Constituted Attorney i.e. Mrs. Meena Bansal. The authorisation letter dated 02.04.2026 issued by plaintiff no.1 i.e. Cross Inc., authorising the said Constituted Attorney to receive the Court Fees is also appended to the present application.
